

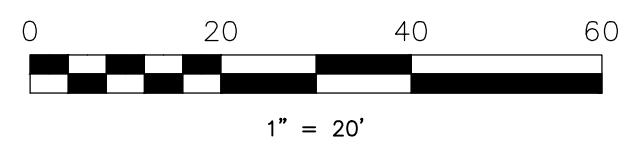
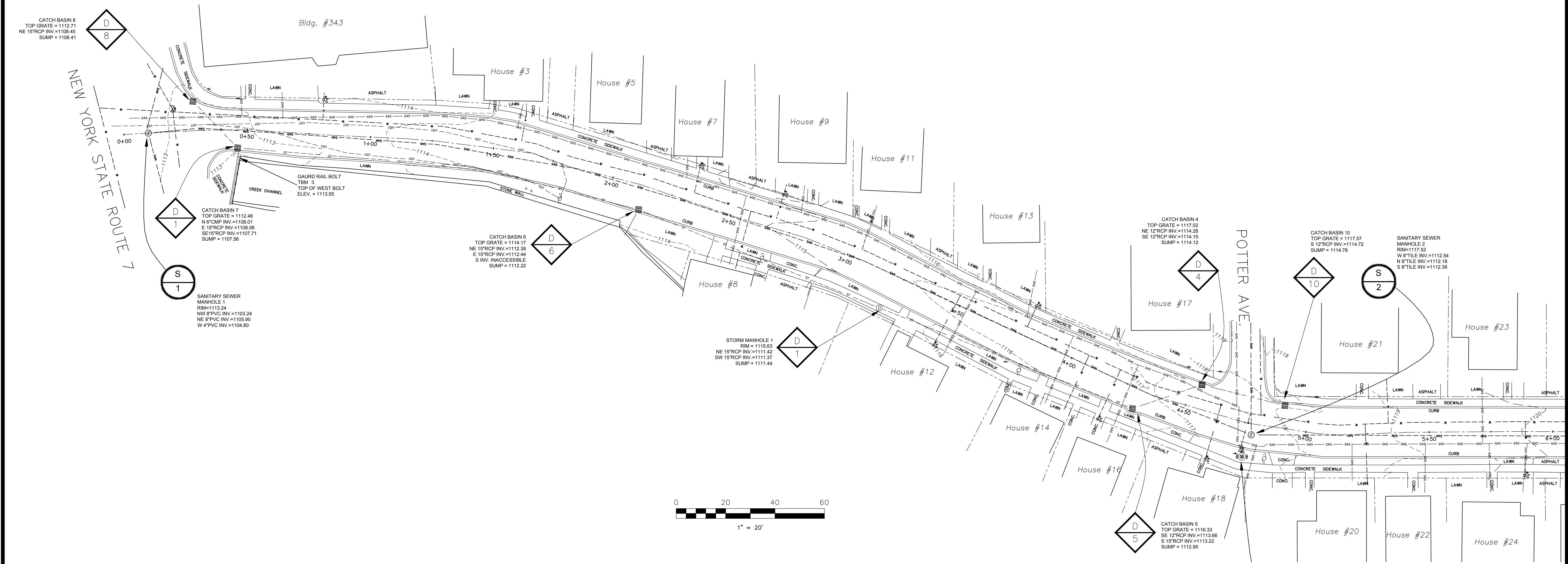
LOCATION MAP
